Introduction

Our brochure provides a small amount of information that we hope will prove valuable in the coming days, however our staff are here to personally help, guide and provide support on all matters relating to the funeral.









Registration and Tell Us Once Service

When a death can be certified by a medical practitioner, the registration should take place within 5 days.

You will need to book an appointment to register the death in the county where the death occurred.

If you use a different register office, the documents will be sent to the office in the area where the person died before they are issued to you. This means that there can be a brief delay.

Who can register a death?

- · A relative
- A person present at the time of the death
- An occupant of the house where the person died
- The person making the funeral arrangements

Most deaths are registered by a relative. The registrar will allow another person to register if relatives are not available.

What the registrar will require:

- The medical certificate of cause of death issued by a doctor
- · Birth certificate
- Council tax bill
- Marriage certificate
- · NHS Medical Card
- · Proof of address (from utility bill)

Should you use the 'Tell Us Once Service' you will require the following additional documents:

- · National Insurance Number
- · Driving Licence Number

- · Vehicle Registration Number
- Passport Number
- Details of any benefits the deceased was in receipt of
- Details of any council services such as blue badge

The registrar will provide you with a telephone number and unique reference number that will enable you to use the Tell Us Once service online or by telephone.

The registrar will need to know the following information:

- The person's full name and date of death
- Any previous names used (e.g. maiden name)
- The person's date and place of birth
- Their last address
- · Their final occupation
- The full name, date of birth and occupation of surviving spouse
- Whether the deceased was in receipt of a state pension or any other benefits

Documents you will be given:

- A certificate for burial or cremation (also known as the green form)
- A certificate of Registration of Death (form BD8)
- Certified copies of the entry in the register (fee applicable)

Deaths reported to H.M. Coroner

Deaths reported to HM Coroner are usually when the death is sudden, unexpected, unnatural or where the cause of death needs further investigation.

We will be able to keep you informed of what is happening and explain registration procedures dependent upon your circumstances.

Who can claim?

You can get help towards the cost of the funeral if you meet the following conditions:

You or your partner are getting one of the following qualifying benefits;

- · Universal Credit
- · Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- · Pension Credit
- Housing Benefit
- The disability or severe disability element of Working Tax Credit
- · Child Tax Credit
- · Support for Mortgage Interest Loan

You can also apply if you or your partner are waiting to hear about the a claim for one of these benefits or payments. We use partner to mean:

- A person you live with who is your husband, wife or civil partner
- A person you live with as if you are a married couple

Bereavement Support Payment Form BSP1

Who can claim?

You could get **Bereavement Support Payment** if at the time of death;

- · You are under State Pension Age
- You were married to and or in a Civil Partnership with person who has died
- Your husband, wife or civil partner has paid enough National Insurance contributions
- · You ordinarily lived in the U.K.

Claims must be made within 3 months of the death of your husband, wife or civil partner. If you leave the claim longer, this will impact on the number of payments and the eligibility for any lump sum payment.

Help with the cost of a funeral may be obtained through the Social Fund. The amount payable is unlikely to cover the cost of the complete funeral.

Should you intend to make an application for financial assistance through the Department of Work and Pensions, this is a private arrangement and in all circumstances you will be

responsible for payment of our account.


